Course Descriptions:

Bird and Wildlife Management at Solid Waste Facilities

8:00am-12:00pm CEUs 0.4 Solid Waste I III/C&D/TS: 4.0

This course explains landfill operations and regulations regarding bird and wildlife management at solid waste facilities. Topics include: habitat and wildlife mgmt, public education and working with environmental groups, threatened species, endangered and nuisance species.

Waste Screening Refresher for Supervisors and Managers

8:00am-12:00pm CEUs 0.4 Solid Waste I III/C&D/TS/MRF/Spotter: 4.0

This course will cover the supervisor's role in waste screening activities at a solid waste facility. This would include regulations, compliance and enforcement, types of waste, screening incoming material, operations plans, health and Safety.

Health and Safety for Solid Waste Workers - 4 hours

1:00pm-5:00pm CEUs 0.4 Solid Waste I III/C&D/TS/MRF/Spotter: 4.0

This course will cover: vehicle and equipment safety, fires and fire fighting, first aid, facility specific situations.

Excavation and Trenching Safety Program

This class provides a brief update for managers and supervisors on OSHA Regulations for trench and excavation, others topics discussed include Competent Person Requirements, OSHA Training Requirements and Soil Types/Hazard Identification.

Permit Required Confined Space Awareness
